Thank you for your interest in becoming a candidate for the Killearn Homes Association (KHA) Board of Directors. As the governing entity serving our nearly 4,000 homes, the nine-member Board provides an excellent opportunity to serve our neighborhood.

There will be five (5) vacancies on the KHA Board next year. To be eligible as a candidate, you must:

- Own property in Killearn Estates;
- Be in good standing with all payments to KHA;
- Available to attend Board meetings, which are held at 6:00 p.m. on the first Tuesday of each month;
- Submit a completed Nomination Application by 5 p.m. on Monday, August 31st, 2026; and
- Be willing to serve a three-year term from January 1, 2027, to December 31, 2029.

Using information from the Nomination Applications submitted by interested members, the Nominating Committee will select the final slate of candidates for inclusion on the ballot. KHA members will then vote on the ballot later this fall, and the five (5) candidates receiving the most votes will be elected to the KHA Board of Directors for a term of three years (January 1, 2027 – December 31, 2029).

We request that you complete the Nomination Application and **submit it to the KHA Office no later than 5 p.m. on Monday, August 31st, 2026.**

Along with your application, please submit a photo and a written biography (no more than 250 words). Please note – the committee cannot make any corrections or edits to these documents. These documents and your responses to this application will be circulated around the community as part of the election process.
